

DATE RESERVATION, DEPOSIT AGREEMENT AND RECEIPT

THIS IS AN AGREEMENT ("Agreement") made and entered into this ___ day of _____, 201___, by and between GatSplat Enterprises LLC a Texas Limited Liability Company located at 582 E Hwy 121 Lewisville, TX 75057, hereinafter referred to as "COMPANY," and

_____, hereinafter referred to as "CLIENT."

RECITALS

COMPANY is in the business of providing a venue for paintball events.
CLIENT desires to retain the COMPANY on the date specified below.

DEFINITIONS

- COMPANY – Gatsplat Enterprises, LLC. A Limited Liability Company organized under the laws of the State of Texas.
- CLIENT – An individual, legal entity or any combination thereof that wishes to retain COMPANY for a private paintball event including, if desired, the rental of equipment necessary to perform said event, on the date specified below.

NOW THEREFORE, the above parties hereby agree as follows:

RESERVATION OF DATE. Upon the terms and subject to the conditions set forth herein, CLIENT hereby reserves ___ day of _____, 201___ starting at the time of _____ for approximately _____ players, as the date and time upon which COMPANY will be engaged to render paintball event services. COMPANY hereby agrees that it will provide paintball event services on the same date to CLIENT unless CLIENT forfeits their rights hereunder by cancelling COMPANY's services. Such cancellation shall occur upon the happening of any the following: delivering a written cancellation notice to COMPANY, failing to fully pay any invoice(s) on the date(s) due to COMPANY, failure to meet any other contractual obligation between CLIENT and COMPANY whether contemplated herein or not or any other event which evidences CLIENT's desire to either not participate in the contemplated event or have another company perform COMPANY's services.

NON-REFUNDABLE DEPOSIT. Company reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Reservation Deposit of \$800 is non-refundable, even if date is changed or the event is cancelled for any reason, including acts of God, fire, strike, or extreme weather. CLIENT agrees to pay \$800 in the form of a non-refundable deposit that will be delivered to COMPANY upon execution of this Agreement, either by check or credit card, either in person, or over the phone.

PRICING OF EVENT The price is \$40.00 per person playing paintball, and includes the use of the facility, the paintball marker (gun), tank, safety goggles, and 300 paintball per player. Additional paintballs can be purchased, and only GatSplat purchased paintballs can be used. There is a \$800, or 20 person minimum. If the group is less than or equal to 20 players, the \$800 will be the charge for the actual number of players that played. For groups over 20 players, additional players will be charged at \$40 per person at the time of the event.

CLIENT'S CAPACITY. By signing below CLIENT represents and warrants to COMPANY that he/she/it has the capacity and right to enter into this agreement and perform the services, duties, or obligations placed upon CLIENT as required by this agreement without any limitation by any agreement, document, restrictive obligation or other limitation. Further, CLIENT acknowledges that s/he/it/they have been advised of the non-refundable nature of the \$800 and have retained a copy of this Agreement as a receipt evidencing the payment of the same.
